- You shall fulfill all other criteria as prescribed under the SEBI (Alternative Investment Funds) Regulations, 2012.

You may note that this approval is granted on the basis of information available with SEBI at this point of time. SEBI retains the right to revoke this in-principle approval, if any facts come to light which are different from the information furnished at the time of filing of application.
